



41st annual Fire-Up & silent auction raises more than \$27,000 to support CALS students and debuts new Red Jacket Daluge Award

Monies raised are used to support UW CALS students through the Outstanding Sophomore Award scholarships and FISC awards. A big thank-you to all of the donors, bidders and volunteers.

But the WALSAA Football Fire-Up isn't all about the money, it was a day that gave old friends time to catch up and reminisce about days on campus.

It was also the day that the inaugural WALSAA Daluge Red Jacket Award was presented for the first time. CALS Message: Reflections on research at CALS



CALS Associate Dean for Research Rick Lindroth

As my six-year tenure as the college's associate dean for research draws to close, I find myself reflecting on what a rich, deep and rewarding experience it has been. Yet in some ways, I can sum it up with the tiny preposition in the title of my position.

I've served as the CALS associate dean *for* research. My job has been to enhance, promote, facilitate and protect the research endeavors of the college. It's not the associate dean *of* research, which puts the emphasis on the person holding the position. One of the things I have most appreciated about being in a leadership position at this university is the humility of my colleagues. Call it Midwestern, if you will – but then also call it effective and alluring. UW–Madison is not about egos. It's about great people doing great things to sustain and advance a great university. And of course CALS is an essential and time-honored part of that effort.

As a professor and researcher with a busy lab, I joined CALS administration with the expectation of new challenges and the hope of positively affecting the college's research enterprise. As many WALSAA members know, that enterprise is varied indeed. I think of it as encompassing three major areas. There's basic life science research, which includes the departments of biochemistry, genetics and bacteriology, as well as basic science conducted across our other departments – the kind of fundamental, curiosity-driven science upon which all other science is built. Then there is applied science; many of our more agronomically- or production-oriented departments fall under that heading. The third area is natural resources and environment, which

entails both understanding and stewarding our natural world.

Some of the things I have appreciated most about my role as dean for research are the quality of our faculty and their collaborative work ethic. CALS faculty are simply extraordinary researchers. And when people at other institutions complain to me about research silos, I wonder, "What are you talking about?" At UW–Madison, faculty are free to collaborate across the college, across the campus, across the world – and they do.

As associate dean, it's been my responsibility to protect and advance research interests in all of our disciplinary areas – a job that would have been impossible without the collaboration and support of our many partners throughout the state. Farmers, commodity and industry groups, businesses, government agencies, nonprofits, schools and other universities – with many of our alumni represented among these stakeholder groups – have been absolutely essential to CALS' research mission.

As I prepare to move back into full-time teaching and research, I'd like to take this opportunity to thank all of you for your help and support. Wisconsin is historically an extraordinary university for science, agriculture, and natural resources. We remain one of the top universities in the country – indeed, in the world – in those areas.

It has been a joy and a privilege to serve the CALS community as associate dean. With your continued engagement and support, I have no doubt that the CALS research enterprise will continue to flourish.

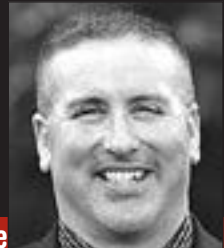
