# **FISC Corner: Generations of FISC** celebrate 127th Anniversary

More than 170 graduates, current students, supporters and friends of the UW-Madison Farm and Industry Short Course (FISC) gathered at the Coliseum Bar and Banquet Hall in Madison on Saturday, Jan. 28 for the 127th anniversary of this well-known agricultural education program.

Since its beginning in 1885, production agriculture has been the focus of the program. Graduates, from as long as 50 years ago to those currently enrolled, speak of the practicality of the coursework and the positive life experiences they gained during their days as FISC students.

Larry Meiller, professor emeritus, Life Science Communications, served as the emcee for the program. William Tracy, interim dean for the College of Agricultural and Life Sciences (CALS) extended greetings and warm wishes. In addition, Sarah Pfatteicher, interim associate dean of Undergraduate Programs and Services, CALS; Jeff Lyon, deputy secretary of agriculture, Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP); and Jill Makovec, president of WALSAA greeted the crowd.

In addition, Bob Kauffman, professor emeritus of the Dairy Science Department, and the Dimensions in Sound provided pre-reunion music crowd in the Badger spirit!

recruitment officer visiting hundreds of Wisconsin agricultural high school classrooms in addition to representing FISC at Farm Technology Days, World Dairy Expo, Wisconsin State Fair, and state and national FFA conventions. She was responsible for the development of the Farm & Industry Short Course Ambassador program and taught the English Composition class for four years.

In 2009, Knipschild was awarded an Honorary State FFA Degree. The national agriculture sorority, Sigma Alpha, honored her with an Ag Advocate Award in the same year. She was the recipient of the State Special Citation Award by the Wisconsin Association of Agricultural Educators at its statewide convention last summer for her work as the FFA CDE Contest manager.

The Service to Agriculture Award was presented to Dr. Richard Cates, Jr., Center for Integrated Agriculture, Wisconsin School for Beginning Dairy and Livestock Farmers and CALS Grazing Systems Programming, for his continued dedication and service to the College of Agricultural and Life Sciences, Farm and Industry Short Course and the Wisconsin agriculture industry. Cates earned his doctorate in 1983 in soil science and plant health from UW-Madison while serving an Aldo Leopold Fellowship. He received his masters degree in soil science from Montana State University in 1979, and

bachelors degree in anthropology and geography from Dartmouth College in 1974. Shortly after completion of the doctorate, he served for eight years as agriculturist with DATCP's Sustainable Agriculture Program.

Dick holds a 75 percent-time appointment within CALS. He is senior lecturer in the Department of Soil Science, director of a new CALS Grazing Systems Programming Initiative, and director of the Wisconsin School for Beginning Dairy & Livestock Farmers (WSBDF; a program of the UW Center for Integrated Agricultural Systems), a program he helped initiate in 1995. The WSBDF, now in its 17th year, emphasizes dairy and livestock farm start-up, managed grazing, and business skill development through classroom curriculum and on-farm internship training. More than 400 students have been enrolled in the WSBDF since the program's inception. The WSBDF was also the first program within CALS to offer classes through Internet distance education. Cates also teaches courses he helped to develop on grassland management and ecology.

He was recognized as the Wisconsin Grazing Community Communicator of the Year in 2009, J.S. Donald 'Excellence in Teaching' award in 2004 from CALS, and the Distinguished Agricultural Award in 2000 from the Kiwanis Club of Downtown Madison.

Dick and Kim Cates and their three children, have operated an 800-acre managed-grazingbeefsteerandcustom dairy heifer business since 1987. In 1989, they began to direct-market beef from their pasture-raised Angus (now also, Jersey) steers; at present they provide Cates Family Farm beef directly to more than 200 households, retail-businesses, and restaurants located in south central Wisconsin, Madison, Milwaukee and the Chicago area.

# **CALS Professor in the Spotlight:** Dr. Dan Schaefer

#### What is your background?

During March 2010 through June 2011, I served as the interim dean for CALS associate Undergraduate Programs & Services. Now, I am back in my department chair and faculty roles.

### WALSAA?

I have been involved with WALSAA since 1981. Upon my return, I remember attending a Football Fire-Up in the Stock Pavilion. I saw my classmates who were now established

# What is the value of WALSAA for

CALS undergraduates come to a big place. The connections that they have with their adviser and instructors carry over into alumni life, as do their undergraduate friendships with peers in their major. Their affiliation with CALS is what started these relationships, and it is WALSAA that facilitates the continuation of these relationships.

My largest project at this time involves a team initiative aimed at developing the private sector financial support to construct a new meat science and muscle biology lab on campus. We aim to recruit \$20 million of support for a project that has an estimated total cost of \$42.8 million. #### What would you like WALSAA members to know about the Animal **Sciences Department?**

The Animal Sciences Department now numbers 19 faculty, 173 undergraduate majors and 35 graduate students. We experienced a nice increase in our number of undergraduate majors with the beginning of fall semester 2011, up from about 145 majors. When the department met with 38 of its freshmen and transfer students on Sept. 1, two-thirds indicated that aspirations of becoming a veterinarian motivated their enrollment in animal sciences, while they all expressed their affection for working with animals.

### WALSAA's beginning

WALSAA initially started as a constituent group of the Wisconsin Alumni Association (WAA) until 1974 when WAA asked it and seven other alumni groups to go on our own. Initial dues were \$10 with WALSAA getting just \$2; lifetime dues were \$150 with WALSAA receiving \$20. In 1974, WALSAA started as an independent, non-for profit, 501(c)(3) group and charged \$10 and \$150, respectively, and all of it went to WALSAA. At the time of the split, WALSAA had around 500 members. Some chose not to stay with WALSAA, but about 350 did. WALSAA honored all life memberships, but did ask that group to make an additional tax deductible contribution. By the end of the first 10 years, WALSAA's roster included about 500 annual members and 300 life members.

The early WALSAA board was small with only six elected members and three ex-officio (the secretary-treasurer, a short course representative and the dean). The first secretary-treasurer was Donald Schwarz. Rick Daluge assumed the role nine months later when Schwarz moved to Milwaukee Technical College. The board was very dedicated often having night meetings in Madison and then driving back to places like Green Bay, Eau Claire, and Milwaukee.

### Life at CALS

• Glenn S. Pound, was dean of the College of Agricultural and Life Sciences from 1964 until he retired in 1979. Much of the college's current focus in basic biological sciences can be traced to Pound's administration, says Leo Walsh, who took over as dean when Pound retired

 The Animal Sciences Building located at 1675 Observatory Drive was dedicated on Nov. 3, 1972. Prior to the completion of this building the faculty were scatted throughout 16 buildings on campus. The building cost just more than \$5 million dollars.

• In 1977, CALS bacteriologists describe site of nitrogen-fixing enzyme in bacteria and unravel the mechanism by which the enzyme is regulated — an important step in long-time research aimed at putting nitrogen-fixing capability into non-legume plants.

• In 1979, CALS food safety researchers provide purified botulinum toxin for first trials with human volunteers. Purified toxin made at CALS was the first to be FDA-approved for use in a revolutionary eye treatment that replaced conventional eye surgery. Botulinum toxin is now also used to treat severe neck cramps, cerebral palsy and migraine headaches - as well as to erase wrinkles.

• In 1980, CALS horticulturists clone a plant gene for the first time.
